Part of retained earnings in portion of EUR 38.645.023,65 (BAM 75.583.096,67 shall be paid to the Bank's shareholders as a dividend for 2022. The dividend per share amounts to 39,09 EUR (76,45 BAM) which equals 30,589 of the nominal value per share. A dividend shall be disbursed to every shareholder of the Bank appearing on the list of shareholders with the Securities Register of the FB&H as of 22.06.2023 which is the date on which the General Meeting of Shareholders shall adopt thi Resolution.
